TERMS AND CONDITIONS

\$80 / \$120 BILL REBATE PROMOTION CAMPAIGN

1. The Bill Rebate promotion “Promotion” is applicable and limited to new household/ residential (Domestic) customers. Existing residential customers of Tuas Power Supply (“TPS”) are not be eligible for this Promotion.
2. This Promotion is for any TPS Electricity Plan sign up (excluding PowerDO6 sign up) from 1 - 19 May 2019. The rebate given to consumers are based on the Tuas Power Electricity Plan signed up, as follows:
 - o \$120 bill rebate for 36 months plan - PowerFIX 36
 - o \$80 bill rebate for any 18 / 24 months plans – PowerDO 24, PowerFIX 18 and PowerFIX 24
3. This promotion cannot be used with another promotion except with a Refer a Friend program.
4. During the \$80 / \$120 bill rebate promotion, the Refer a Friend online program (“RAF”) is combined for the referrer (existing customer sharing their Refer A Friend code) who shall be entitled to a \$20 bill rebate (when the referee is successfully transferred) only under the RAF & this promotion. The referee (new customers / new homes signing up with a referral code) will be entitled to a \$80/ \$120 bill rebate (depending on the electricity plan selection). There will be no further add on or rebates to the referee under the RAF. This is limited to online sign up and will not be available at roadshow. Except for the revised bill rebate amount, the Terms and conditions of the RAF will apply.
5. This promotion can be used for online and roadshow sign up.
6. The bill rebate will be credited to consumers in their second or third bill (depending on their SP billing cycle), after successfully transferred to Tuas Power.
7. The bill rebate is inclusive of GST and can be used to offset the SP bill. If there should be balance credits, it will be utilized to offset the next month’s bill or until it is fully utilized.
8. This Promotion shall be read in conjunction with TPS’ standard terms and conditions of electricity product.
9. In the event of early termination prior to the expiry of the electricity retail agreement for whatsoever reason, TPS shall (i) charge an early termination charge of \$200 as set out in the electricity retail agreement and (ii) claw back the bill rebate amount in full.
10. Successful sign-ups will be liable to pay an admin fee of \$10.70 (including GST) for any changes to their promotion code or electricity plan made 3 days before date of transfer of electricity account to TPS.
11. The bill rebate is not transferable nor exchangeable for cash. TPS reserves the right to replace with different incentives of similar value, modify or terminate the Promotion at any time and without prior notice.
12. The decisions of TPS in respect of any and all aspect of this Promotion will be final and binding.
