TERMS AND CONDITIONS HUAT WITH TOTO128

1. The HUAT WITH TOTO128 (“Campaign”) is applicable and limited to new household/residential (Domestic) customers. Existing residential customers of Tuas Power Supply (“TPS”) are not eligible for this Campaign.
2. **By signing up for an electricity plan, you hereby agree to all the terms and conditions set forth herein for this Campaign.**
3. This Campaign is only **limited to customers who sign up online, over the phone or at Tuas Power 111 Somerset (Level 1) booth** using the campaign code – **TOTO128** and cannot be used with any other Campaign program, unless otherwise specified.
4. This Campaign is for any TPS Electricity Plan signed up **from 28 January – 28 February 2021**, limited to the first 100 (one hundred) customers only. The first 100 (one hundred) customers who have successfully transferred their account to TPS will be entitled to the following welcome entitlement: -

5. Customers are encouraged to take their own meter reading and submit the meter reading to SP Services Limited (“SP”) to avoid any estimated bill(s) for the month. The submission date for meter reading will be indicated in SP’s transfer date notification letter. Customers are solely responsible to make the necessary arrangements for such meter reading.
6. The bill rebate is non-transferable, non-exchangeable and not redeemable for cash. TPS may, in its sole discretion, substitute the Entitlement or cancel this Campaign, without prior notice to any person. TPS at its sole discretion reserves the right to modify the Terms and Condition of the Campaign from time to time, without prior notice.
7. The bill rebate will be credited to customers in their second or third bill (depending on their SP billing cycle), after their account has been successfully transferred to Tuas

Power. The bill rebate is inclusive of GST and can be used to offset the SP bill. If there should be any rebate balance credits, it will be utilized to offset the next month's bill and so forth until it is fully utilized.

8. By providing TPS with the registration/personal data and all other information (including his/her name, last 4 digits of NRIC, contact details or address), you hereby consent to the collection, use and disclosure of your personal data to TPS (including its affiliates, employees, sub-contractors, agents, representatives and/or its third party service providers) for the purposes of TPS' electricity business or related activities by TPS (including processing of your application and entry or execution of the electricity retail agreement) and future correspondences.
9. This Campaign program shall be read in conjunction with TPS' standard terms and conditions of electricity product.
10. In the event of early termination prior to the expiry of the electricity retail agreement for whatsoever reason, TPS shall (i) charge an early termination charge of \$200 as set out in the electricity retail agreement and (ii) claw back the bill rebate amount awarded in full.
11. Successful sign-ups will be liable to pay an administration fee of \$10.70 (including GST of 7%) for any changes to their Campaign program code or electricity plan made 3 days before date of transfer of electricity account to TPS.
12. The decisions of TPS in respect of any and all aspect of this Campaign program shall be final and binding.
13. By participating in the Facebook Live activities, each participant hereby agrees that TPS may use the information collected at the Facebook Live and is deemed to have given TPS his/her consent to the collection, usage, storage, disclosure and processing of information about the participant. In addition, the participants agree that TPS shall have the right at any time to contact and/or mail the participants (whether electronically or otherwise) with promotional materials, information and/or mailers. It is deemed that the participants have consented to being featured in photographs, motion pictures, recordings, or any other media records for the purpose of promotion by TPS or for any legitimate purpose, including any commercial and marketing uses, and/or to be updated onto TPS public websites and channels.
