TERMS AND CONDITIONS MOVIE TICKETS CAMPAIGN

1. The Movie Tickets campaign (“Promotion”) is only applicable and limited to new household/ residential (Domestic) customers. Existing residential customers of Tuas Power Supply (“TPS”) are not be eligible for this Promotion.
2. This Promotion is limited to only the first 20 customers who sign up for PowerFIX 36 electricity plan online every Tuesday and Thursday from 1 October – 28 November 2019 (“Promotion Period”) using the campaign code – TPMOVIE.
3. This Promotion is limited only to online sign up and is not available at any of TPS’ roadshows.
4. This Promotion cannot be use with other promotions or program, unless otherwise specified.
5. Customers participating in this Promotion will be entitled to a \$100 bill rebate and 2 (two) Cathay Cineplexes movie tickets (“Movie Tickets”) upon signing up AND upon the successful transfer of the Customer’s account to TPS. Any Referral program will not be applicable for this Promotion.
6. After the successful transfer of the Customer’s account to TPS, the Customer(s) will receive a notification letter from TPS for the collection of the Movie Tickets at TPS’ Somerset office.
7. The bill rebate will be credited to consumers in their second or third bill (depending on their SP billing cycle), after their accounts have been successfully transferred to TPS. The bill rebate is inclusive of GST and can be used to offset the SP bill. If there should be any balance credits, it will be utilized to offset the next month’s bill and so forth until it is fully utilized.
8. This Promotion shall be read in conjunction with TPS’ standard terms and conditions of electricity product.
9. In the event of an early termination prior to the expiry of the electricity retail agreement for whatsoever reason, TPS shall (i) charge an early termination charge of \$200 as set out in the electricity retail agreement and (ii) claw back the bill rebate amount in full.
10. Successful sign-ups will be liable to pay an administration fee of \$10.70 (including GST) for any changes to their promotion code made 3 days before date of transfer of electricity account to TPS.
11. Under no circumstances shall TPS be liable for the quality, merchantability or the fitness of the Movie Tickets and the Movie Tickets shall only be used at participating outlets.
12. Once given, TPS shall also not be liable for any compensation and/or any reimbursement in cash or otherwise should the Movie Tickets be rejected and/or damaged and/or lost and/or have lapsed.
13. The bill rebate is non-transferable, non-exchangeable and not redeemable for cash. TPS may, in its sole discretion, substitute the rebate or cancel this Promotion, without prior notice to any person. TPS at its sole discretion reserves the right to modify the Terms & Condition of this Promotion from time to time, without prior notice.
14. The decisions of TPS in respect of any and all aspect of this Promotion will be final and binding.
