## TERMS AND CONDITIONS

### EXCLUSIVE PROMOTION FOR OCBC RENOVATION LOAN CUSTOMERS

1. This Exclusive Promotion for OCBC Renovation Loan Customers ("Campaign") is only applicable to successful applicants of OCBC Bank ("OCBC") renovation loan (via <https://www.ocbc.com/personal-banking/loans/home-renovation-loan>) as notified by OCBC, during the period of 5 May 2020 to 31 December 2020 (both dates inclusive).
2. **By signing up for an electricity plan, you hereby agree to all the terms and conditions set forth herein for this Campaign.**
3. This Campaign is limited to new household/residential (domestic) customers. Existing residential customers of Tuas Power Supply ("TPS") are not eligible for this Campaign.
4. This Campaign is **limited to online sign-ups only** using the campaign code – **OCBC520** and cannot be used in conjunction with and/or combined together with any other campaigns or promotion programs, unless otherwise specified.
5. This Campaign is for TPS Electricity Plans signed up **from 5 May 2020 to 31 December 2020 (both dates inclusive)** or otherwise specified by TPS ("Campaign Period"). Successfully transferred customers will be entitled to the following: -

6. After the successful transfer of the Customer's account to TPS, the Customer(s) will receive a notification letter from TPS stating the location and timing for the collection of the FairPrice vouchers.
7. The FairPrice vouchers are non-transferable, non-exchangeable and not redeemable for cash. TPS may, in its sole discretion, substitute the FairPrice vouchers or cancel this Campaign, without prior notice to any person. TPS at its sole discretion reserves the right to modify the Terms and Condition of the Campaign from time to time, without prior notice.
8. This Campaign shall be read in conjunction with TPS' Standard Terms and Conditions of Electricity Retail Agreement.
9. In the event of early termination prior to the expiry of the electricity retail agreement for whatsoever reason, TPS shall (i) charge an early termination charge of \$200 as set out in the electricity retail agreement and (ii) claw back the awarded FairPrice vouchers amount in full from the customer.
10. Successful sign-ups will be liable to pay an administration fee of \$10.70 (including GST of 7%) for any changes to their Campaign program code or electricity plan made 3 (three) days before

the date of transfer of the customer's electricity account to TPS and the commencement date of the electricity retail agreement will be delayed accordingly.

11. Under no circumstances shall TPS be liable for the quality, merchantability or the fitness of the FairPrice vouchers; and the FairPrice vouchers shall only be used at participating outlets.
