



TERMS AND CONDITIONS UP TO \$80 BILL REBATE PROMOTION

1. The Up to \$80 Bill Rebate Promotion (“Promotion”) is applicable and limited to new household/ residential (Domestic) customers. Existing residential customers of Tuas Power Supply (“TPS”) are not be eligible for this Promotion.
2. **By signing up for an electricity plan, you hereby agree to all the terms and conditions set forth herein for this campaign.**
3. This Promotion is **limited to customers who signed up during TPS’ booth** and cannot be used with any other promotion program, unless otherwise specified.
4. This Promotion is for any TPS Electricity Plan signed up (excluding PowerDO6 sign up) **from 7 - 21 September 2020**, for the first 2,000 customers only. Successfully transferred customers will be entitled to the following:

PowerDO 24	22% Discount off Tariff	\$20 Bill Rebate + \$10 Grocery Voucher

5. The bill rebate or grocery voucher (“Entitlement”) is non-transferable, non-exchangeable and not redeemable for cash. TPS may, in its sole discretion, substitute the rebate or cancel this Promotion program, without prior notice to any person. TPS at its sole discretion reserves the right to modify the Terms and Condition of the Promotion from time to time, without prior notice.
6. The bill rebate will be credited to customers in their second or third bill (depending on their SP billing cycle), after their account has been successfully transferred to Tuas Power. The bill rebate is inclusive of GST and can be used to offset the SP bill. If there should be any rebate balance credits, it will be utilized to offset the next month’s bill and so forth until it is fully utilized.
7. This Promotion program shall be read in conjunction with TPS’ standard terms and conditions of electricity product.
8. In the event of early termination prior to the expiry of the electricity retail agreement for whatsoever reason, TPS shall (i) charge an early termination charge of \$200 as set out in the electricity retail agreement and (ii) claw back the Entitlement amount in full.

9. Successful sign-ups will be liable to pay an administration fee of \$10.70 (including GST of 7%) for any changes to their promotion program code or electricity plan made 3 days before date of transfer of electricity account to TPS.
10. Under no circumstances shall TPS be liable for the quality, merchantability or the fitness of the grocery vouchers; and the grocery vouchers shall only be used at participating outlets.
11. TPS shall also not be liable for any compensation and/or any reimbursement in cash or otherwise should the grocery vouchers be rejected and/or damaged and/or lost and/or have lapsed.
12. The decisions of TPS in respect of any and all aspect of this Promotion program shall be final and binding.
13. By participating in the Booth activities, each participant hereby agrees that TPS may use the information collected at the TPS Booth and that each the participant has given TPS consent to the collection, usage, storage, disclosure and processing of information about the participant. In addition, the participants agree that TPS shall have the right at any time to contact and/or mail the participants (whether electronically or otherwise) with promotional materials, information and/or mailers. It is deemed that the participants have consented to being featured in photographs, motion pictures, recordings, or any other media records for the purpose of promotion by TPS or for any legitimate purpose, including any commercial and marketing uses, and/or to be updated onto TPS public websites and channels. The participants further agrees that TPS may disclose and publish his/her name and other of his/her particulars (including but not limited to his/her photographs) for the purposes of publicity by TPS.
